**Lesson 10 – The Pharmakeia Scam Part 2**  
**Bible Sermon Study Notes by Cary Rodgers, pastor**

**Who is the father of modern pharmacy and where did he get his inspiration?**

Born as Philippus Aureolus Theophrastus Bombastus von Hohenheim in 1493. He called himself Paracelsus. He was well known as a Swiss German physician, botanist, alchemist, astrologer, and general **occultist (belief in dark magical powers similar to voodoo, sorcery, or necromancy; Satan worshiper)**. He founded the field of toxicology better known as pharmacy.

For many years physicians used natural herbs and food for healing. Even the famous Greek physician Hippocrates, before Paracelsus, said "let food be your medicine." Paracelsus defied this notion.

From his studies on chemistry and metallurgy with the mix of occultic worship and astrology he theorized that metals such as mercury, lead, tin, copper, and gold can "purify" the body. He believed that the stars and planets were the main cause of human illness and disease and that ALL diseases should be treated with metals / poison.

This was a very radical practice during his time. He treated many diseases with mercury better known as quicksilver. Many physicians who bought into Paracelsus method used quicksilver (mercury) also known as Quack Salber, for which they were known as "quacks", which was a mockery of this rebellious treatment of the body at the time. (Back to Eden, Jethro Kloss, p. 52-53. Many died as a result of Paracelsus way of treatment.

At 50 or 51 years old, the story is told that Paracelsus was thrown out the window by other physicians at the time who believed him to be very dangerous in 1541.

But it is amazing today the Paracelsus is considered the father of modern pharmacy! Where did he get his inspiration. Satan!

**WARNING! Modern Medicine – Uses poisonous drugs from the snake, Satan, himself.**

**This system of Paracelsus is the foundation in which modern medicine is built. It has killed and poisoned millions of people.** Pharmaceutical drugs never cure disease – they only try to manage it by inhibiting or manipulating a function in the body that is supposed to happen naturally.

- In a June 2010 report in the *Journal of General Internal Medicine*, study authors said that in looking over records that spanned from 1976 to 2006 they found that, of 62 million death certificates, **25 million deaths** were coded as having *occurred in a hospital setting due to medication errors*.
- The total number of deaths due to the American modern medical system of drugging, unnecessary surgeries, infections, medical errors, etc is 783,936 people per year! ### **Rx symbolizes prayer to the god of medicine-Jupiter**

Coming from the practice of Egyptian pagan worship, the Rx originally was the eye of Horus that doctors used as a sign for help and healing from the god of Horus. But overtime the eye of Horus was abbreviated as R with the bottom of the R crossed.

"The sacred monogram Chi-Rho, so called because it composed of the Greek letters chi © and rho ] (R), is of Egyptian origin. According to Sir Flinders Petrie, the Egyptologist, the monogram Chi-Rho was the emblem of the Egyptian god, Horus, thousands of years before Christ. This is the same as the Rx just the x moved over to the center of the R.

**Revelation 9:20, 21**

20 “And the rest of the men which were not killed by these plagues yet **repented not** of the works of their hands, that they should not worship devils, and idols of gold, and silver, and brass, and stone, and of wood: which neither can see, nor hear, nor walk:

21 **Neither repented they of their murders, nor of their sorceries [pharmakeia]**, nor of their fornication, nor of their thefts.”

Greek word for “sorceries” in verse 21 is pharmakeia. The wicked who got rich from the system of poisoning will not repent even while suffering from the six plague.

“Dr. Farid Fata, 50, pleaded guilty in September to giving cancer treatments to misdiagnosed patients, telling some they had a terminal blood cancer called multiple myeloma. He pleaded guilty to 13 counts of Medicare fraud, one count of conspiracy to pay or receive kickbacks and two counts of money laundering.”

Patty Hester went to Fata in 2010 after being recommended by another doctor. Her white blood cell counts were low, and Fata was a renowned hematologist and oncologist.

"He was, according to the web page, and according to the fliers, he's world-renowned," Hester said. "When you went in his office, he was top doc."

"The quest for power is self-destructive," he said, according to WDIV. "They came to me seeking compassion and care. I failed. Yes, I failed."

“Federal prosecutors are charging 60 doctors, pharmacists, medical professionals and others in connection with alleged opioid pushing and health care fraud, the Justice Department said Wednesday.

The cases involve more than 350,000 prescriptions for controlled substances and more than 32 million pills — the equivalent of a dose of opioids for “every man, woman and child,” across Ohio, Kentucky, Tennessee, Alabama and West Virginia, said Assistant Attorney General Brian Benczkowski.

“The company identified about 8,300 “potentially suspicious ‘orders of interest,’ including thousands of oxycodone orders,” between 2012 and 2016, but only reported four, the U.S. attorney said.

In that time, Rochester Drug Co-Operative’s sales of oxycodone tablets grew almost nine-fold, from 4.7 million to 42.2 million, prosecutors said. Their fentanyl sales grew from approximately 63,000 dosages in 2012 to more than 1.3 million in 2016.”

### **Bingham Farms doctor convicted of running \$35 million pill mill**

“A federal jury on Monday convicted a Bingham Farms doctor of running a \$35 million pill mill that prosecutors say stole money from the government and private insurers and fed America's opioid addiction — all while a greedy doctor lined his own pockets.

After a two-month-long trial, the jury found David Jankowski, 62, guilty on 30 charges related to a scheme that ran out of Summit Medical Group, a purported medical clinic formerly located in Dearborn Heights.

According to evidence presented at trial, Jankowski wrote medically unnecessary prescriptions for highly addictive pain pills, including Oxycontin, Oxycodone, morphine, hydrocodone, and Xanax. He also prescribed drugs after receiving cash from patient recruiters who brought patients to his practice.

This proved lucrative, prosecutors said, alleging Jankowski received more than \$29.3 million from auto and private insurance companies he conned, and more than \$6 million from Medicare and Medicaid.

Jankowski was convicted of 30 of the 32 counts he was charged with and faces up to 20 years in federal prison when he is sentenced in November.

Jankowski is among more than 65 doctors in southeastern Michigan who over the last five years have been charged and/or convicted with running pill mill operations.”

### **What message does the Bible give for those in pharmakeia – the poison of Babylon?**

#### **Galatians 5:19-21**

**19** Now the works of the flesh are manifest, which are *these*; Adultery, fornication, uncleanness, lasciviousness,

**20** Idolatry, witchcraft, hatred, variance, emulations, wrath, strife, seditions, heresies,

**21** Envyings, murders, drunkenness, revellings, and such like: of the which I tell you before, as I have also told *you* in time past, that they which do such things shall not inherit the kingdom of God.

The Greek word for “witchcraft” in verse 20 is pharmakeia. Those who are in this poisoning drugging business who do not repent will not inherit the kingdom of God. This is confirmed in the book of Revelation.

#### **Revelation 21:7-8**

**7** He that overcometh shall inherit all things; and I will be his God, and he shall be my son.

**8** But the fearful, and unbelieving, and the abominable, and murderers, and whoremongers, and

sorcerers, and idolaters, and all liars, shall have their part in the lake which burneth with fire and brimstone: which is the second death.

#### Revelation 22:14-15

14 Blessed *are* they that do his commandments, that they may have right to the tree of life, and may enter in through the gates into the city.

15 For without *are* dogs, and sorcerers, and whoremongers, and murderers, and idolaters, and whosoever loveth and maketh a lie.

Pharmakeia is a part of Babylon. This is what the Bible predicts that Babylon would use to deceive all nations. You don't have to be deceived. There is no way to be a part of God's true people at the end of time and be connected with this system of administering poisonous drugs that manipulate and confuse the mind.
